Summary:

Throughout the creation of the Paddle Prairie Metis Settlement Land Use Plan, it was determined by Council, Administration, and members of the community that there were many lands within the Settlement that required legal land surveying to be completed. The intention of surveying and registering the lands is to provide a foundational base cadastral map of the Hamlet that will assist future subdivision of land, delegation and transfer of parcels to members, and various economic development initiatives that require an understanding the legal land framework.

The most recent registered plan for the hamlet core area was registered with the Metis Settlement Land Registry in 1991 (See *Attachment 1: Plan 900007*). Also attached (*Attachments 2 and 3*) are the interest holders that designate the Metis Title holders, rights of way, easements, and allocations on each parcel.

There are current and future agreements on the land between member and non-member entities that dictate the terms of specific agreements on that land. A legal survey can show where the agreed boundaries are located both on the ground and in the digital world. Official registered plans of survey can physically and digitally show the details of allotments, transfers, ownership, leases, and permits. Once surveys are completed using traditional surveying techniques, the details can be managed in an internal GIS (geographic information system). Having registered surveyed lands creates a framework of proper land management within the community.

The following timelines are based on a cursory review of the registered plans from 1991 and may need some adjustment depending on the final scope of the survey, the condition of survey monuments, the time of year during which the survey is completed, and other factors.

To survey the area for the purpose of creating a cadastral base map of the hamlet area, it is anticipated that a field crew would need to be on site for 4-5 days to locate and measure all survey evidence within the subdivision. Over the course of the field survey, the data from the survey would be processed and assessed by an Alberta Land Surveyor who would calculate the parcel boundaries and the positions of any

corners where survey evidence had been lost or destroyed since 1991. If the community would like to see the lot lines on the ground a field crew could stake the parcel boundaries, this work would take an anticipated additional 4-5 days of field work.

During the survey, it is recommended to measure any permanent improvements (buildings, fences, etc.) that are built outside of the surveyed parcels or that encroach from one parcel to another. Having this information would be helpful if any future re-subdivision is desired or if neighboring title holders are looking to adjust their lot lines to fit their respective needs.

Additional surveying of lots and amenities outside of the hamlet core would require additional scoping and assessment.

Anticipated Resourcing Requirements

The following is a breakdown of what 5 days of survey may look like with a two-person survey crew mobilizing from Edmonton to complete the work. The information below is very high level and will be subject to change depending on the finalized scope of the project, condition of the survey monumentation, and desired deliverables. The field costs include all standard survey equipment (GPS, truck, etc) but do not include specialized equipment such as a drone if required as part of the scope. The costs below do not include any plan production or the physical re-establishment of survey monuments in the field. Once a better sense of the scope is determined, a more solidified estimate can be provided. The following is based on 5 days in the field to search for and measure existing survey evidence defining parcels within subdivision plan 900007. The calculation of property boundaries, utility rights of way and any additional research into interest holders on title will require additional office calculations and data processing depending on the final scope of work and the condition of the survey evidence existing. The following preliminary resources are anticipated to complete the recommended survey activities:

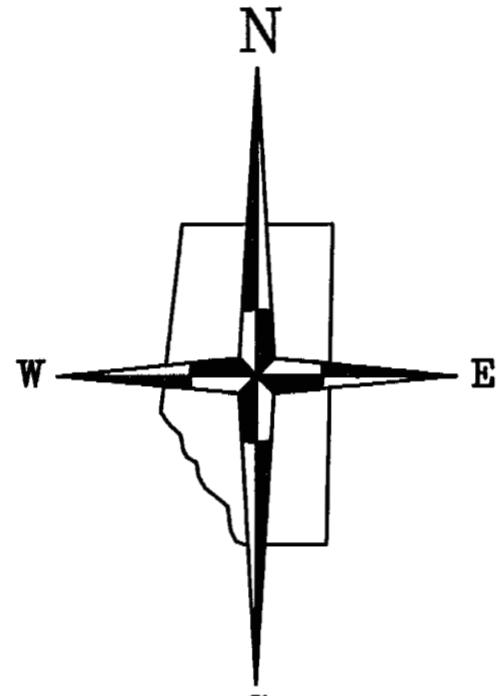
